**NOTIFICATION.**

No. TOSD/Mutation Fee/2014/26365-402. In exercise of the powers conferred by Section-46 of West Pakistan Land Revenue Act, 1967 (W.P..Act-XVII of 1967) and in supersession of all previous notifications, the Board of Revenue, Khyber Pakhtunkhwa hereby directs that **mutation fee** for entries relating to acquisition of any right or interest in an estate made in a mutation register regarding various transfers of properties shall, with effect from the **first day of July, 2018**, be charged in accordance with the Table given below:-

S.No.	Nature of transfer	Mutation fee to be charged
1.	By inheritance	No fee
2.	By partition	No fee
3.	By gift to a legal heir (TAMLEEK)	No fee
4.	By exchange of agriculture land within the same revenue circle	<p>a. One Thousand rupees where the land does not exceed five acres and</p> <p>b. One Thousand plus 500 rupees for every acres or part thereof in excess of five acres.</p>
5.	Transfer made to a wife in lieu of dower (Haq-e-Mehar) acceding to Islamic Law (Sharia)	All the same rate as fixed for transfer at serial No. 4.
6.	Transfer in pursuance of a duly registered deed.	Rs. 100 up-to 5 Kanals and Rs. 50 for each Kanal exceeding 5 Kanals.
7.	Transfer in pursuance of a verdict of a court.	<p>Subject to serial No. 1, 2, 3</p> <p>a. Mutation Fee shall be applicable, unless specifically exempted by a competent court of law.</p> <p>b. In case of pre-emption the decree holder shall deposit additional amount of mutation fee on enhanced sale consideration as the case may be.</p>
8.	Transfer of property through a mode other than those mentioned at Serial Nos. (1) to (7) above.	At the rate of 2% of the value of the property so transferred,

- The fee in respect of transfer covered by serial No. (8) shall be charged in case mutation is accepted.
- Fee at the rate fixed for transfer covered by serial No. 8 shall be charged in relation to gift mutation where accepted, if the gift is in favour of a person other than legal heirs.


